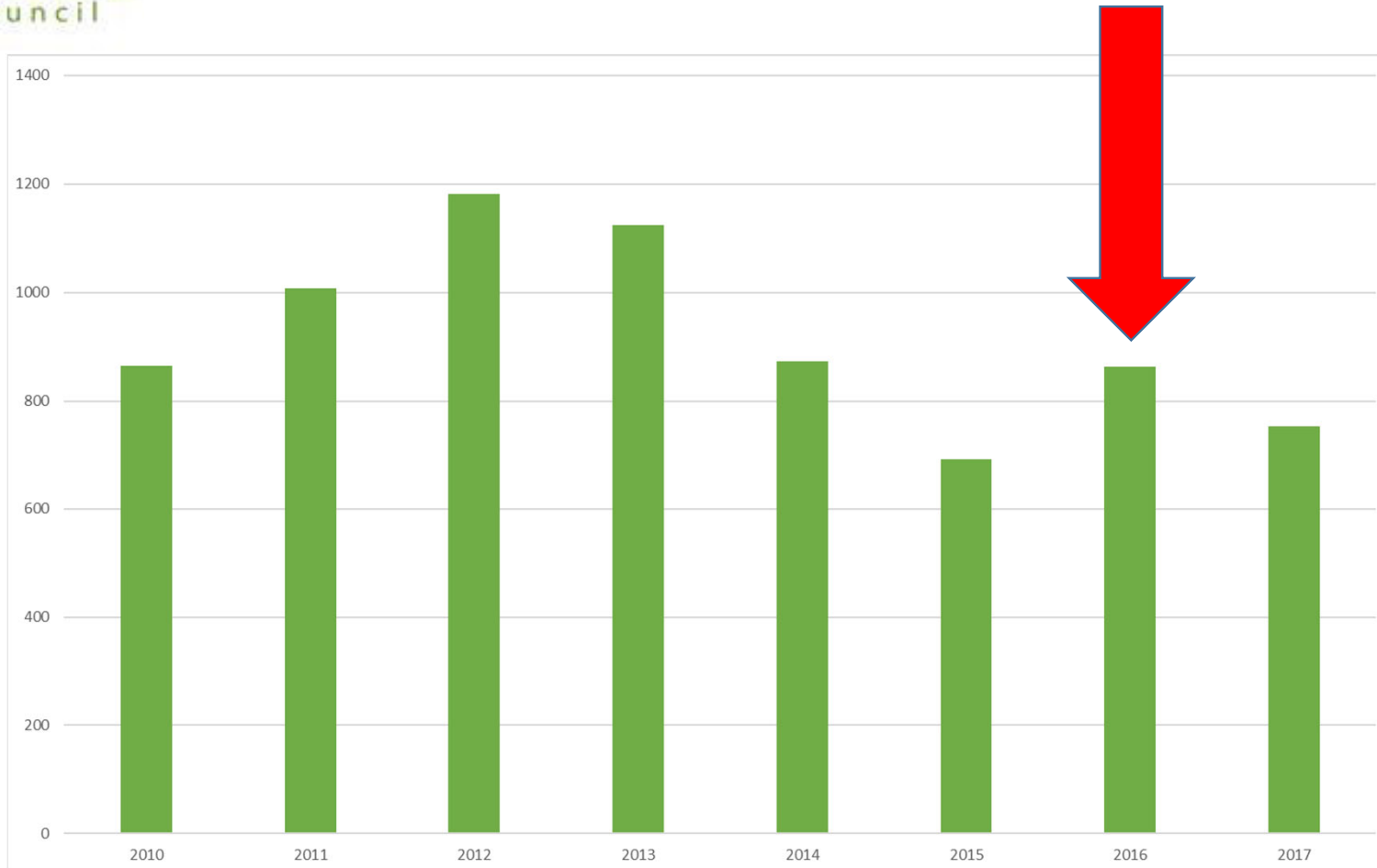


In April 2016 Leicestershire County Council made changes to their recycling and household waste sites implementing revised opening times and charges for non household waste at each of their 14 sites.

North West Leicestershire District Council experienced a slight increase in fly tipping after the revised opening times and charges, most noticeable at our Bring Sites.

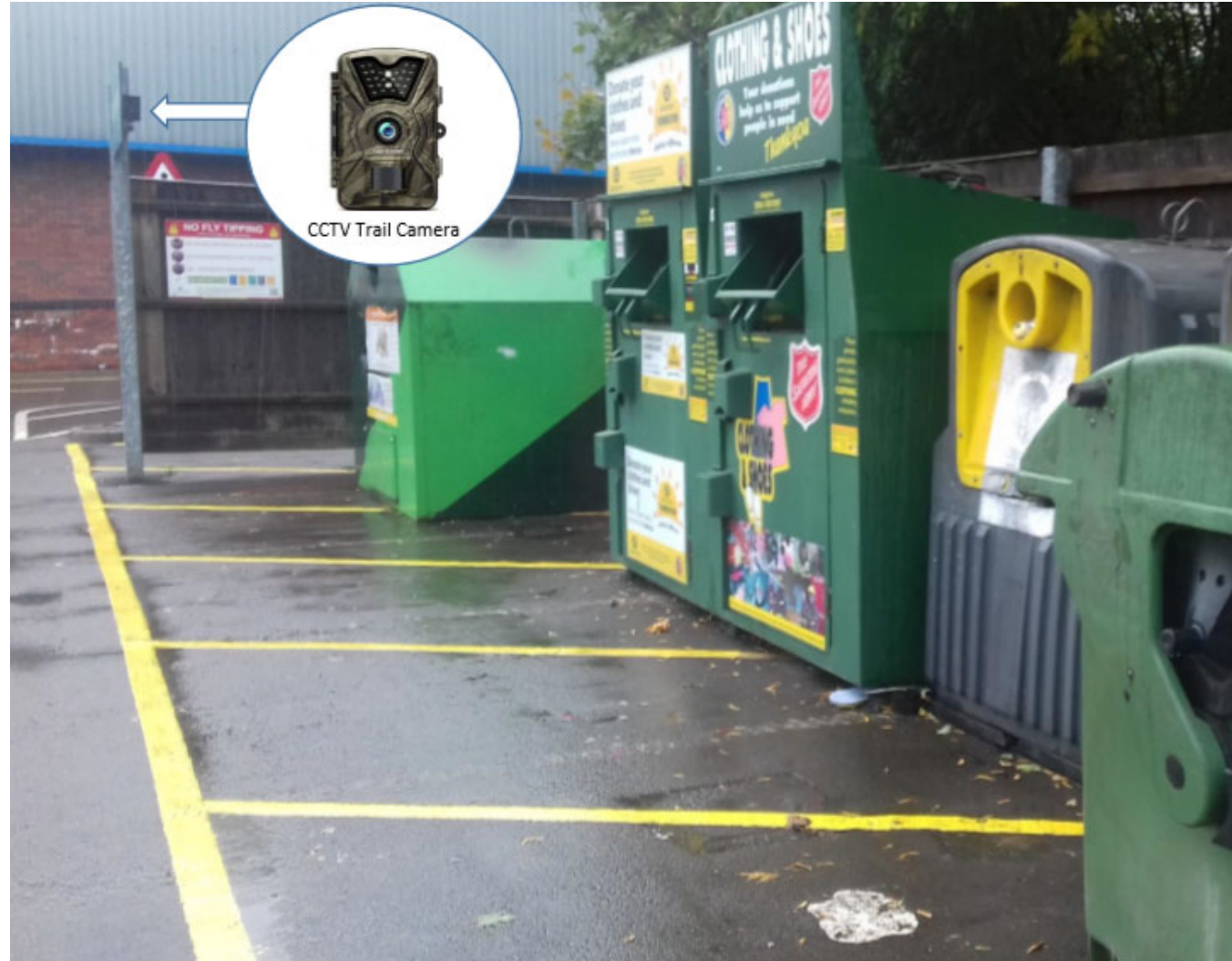

Wildlife trail cameras were also used as cheap alternatives which enabled 24 hour monitoring of the site.



In 2017/18 the Council investigated 49 cases of fly tipping at Bring Site's resulting in 43 Fixed Penalty Notices being issued for littering and 6 for fly tipping.

In an attempt to change peoples behaviour a week of roadshows were held in November 2017 to engage and educate the public who use the sites.



Old signage was replaced with this easy to read design using a QR Code for more detailed information from the Councils waste and recycling page on the website.

RESULTS

Figures taken from the 1st quarter of 2018 show a 47% drop in Fixed Penalty Notices being issued, our Street Cleansing Department have also reported a substantial difference with their team not having to attend to the site on daily basis.
