Purpose of report	To advise members of a recommendation made by the Hackney Carriage and Private Hire Drivers' Consultative Forum to vary the hackney carriage fare table.		
Strategic aims	To review the hackney carriage fare table.

Recommendations	THAT THE FORUM'S REQUEST NOT TO VARY THE HACKNEY CARRIAGE FARE TABLE OTHER THAN BY REMOVING THE 58P PER JOURNEY EXTRA CHARGE FOR EACH DOG CARRIED (EXCEPT GUIDE DOGS WHICH TRAVEL FREE) BE CONSIDERED.

1. LEGISLATION

- 1.1 The District Council has power under Section 65 of the Local Government (Miscellaneous Provisions) Act 1976 to set fares for hackney carriages.
- 1.2 A review of the hackney carriage fare table is usually undertaken at a meeting of the Hackney Carriage and Private Hire Drivers' Consultative Forum each year. All licensed hackney carriage and private hire drivers and operators of private hire and hackney carriage companies were invited to attend the February Forum meeting. It was attended by 8 licensees.
- 1.3 This report is presented following the discussion at the Hackney Carriage and Private Hire Drivers' Consultative Forum meeting held on Wednesday, 22 February 2006.
- 1.4 The Council's current hackney carriage fare table is attached as appendix A to the report.
- 1.5 At the meeting, the Chairman invited any proposals to amend the hackney carriage fare table. Two proposals were made. Firstly, it was proposed that the hackney carriage fare table not be amended. It was felt that a meaningful increase in the fares would actually harm the trade. Secondly, drivers at the meeting agreed that the extra charge of 58p per journey for each dog carried (except guide dogs which travelled free) was an irrelevance and it was proposed that this extra charge be removed from the hackney carriage fare table.
- 1.6 If the Committee approves the request to vary the table of fares then officers would need to publish the proposed variation in a local newspaper giving at least 14 days for objection. If objections are not received then the variation will take effect on a date specified in the notice. However the local authority must consider any objections received and can either revise the fare table in the light of those objections or the fare table, as originally proposed, would come into effect on a new date within 2 months of the original date.

2. OPTIONS

2.1	The local authority may decide to make or not make any changes to the fare table.

(b)	For each journey begun or ended on Christmas Day, Boxing Day and New Year's Day and for each journey made after 6.00pm on Christmas Eve and New Year's Eve and for each journey begun or ended between midnight and 6.00am on 27 December and 2 January.	Double fare
(c)	For all journeys made by vehicles which can accommodate between 5 and 8 passengers.	Normal fare + 50%
(d)	For each dog carried (except guide dogs which travel free)	58p per journey
(e)	Soiling charge	£50.00
