1.0 Background

- 1.1 The District Council has power under Section 65 of the Local Government (Miscellaneous Provisions) Act 1976 to set fares for hackney carriages. A list of fares is collated in the Hackney Carriage Fare Table.
- 1.2 The last increase in the Hackney Carriage Fare Table took place on 25 April 2011 with a 10p increase in the fare up to and including the first mile.

2.0 Current Position

2.1 Representations have been received from the hackney carriage trade ("The Trade") at the Hackney Carriage and Private Hire Drivers' Consultative Forum on 17 May 2012. The Trade made the point at the meeting that they have found it difficult to absorb the rising costs in fuel, insurance and maintenance.

- 2.2 The trade were in agreement that there should be an increase of 10p in the fare table from £3.60 to £3.70 for up to and including the first mile. It was requested that this be presented to the District Council Licensing Committee for approval.
- 2.3 Should the Committee approve the recommendation, officers will publish the proposed variations in a local newspaper, giving at least 14 days for objection. If no objections are received, then the new fares will take effect on a date specified in the notice.
- 2.4 If objections are received, the local authority must consider any objections received and can either revise the fare table in light of those objections or the fare table as originally proposed will come into effect on a new date, within 2 months of the original date.
- 2.5 The Council's current hackney carriage fare table with the proposed fares is attached as **Appendix A**.
- 2.6 Should Members be minded to approve the proposed increase, the Committee is requested to delegate authority to the Environmental Health Team Manager to resolve any objections received.
- 2.7 The Committee are further requested to delegate authority to the Environmental Health Team Manager to approve the increase and adjust the Fare Table once the 14 day consultation has ended, enabling the decision making process to remain efficient.

3.0 Future Provision

- 3.1 The Hackney Carriage Trade have requested a further increase in the fare table from April 2013.
- 3.2 To give stability to the trade it is proposed that there is a 5 pence rise (in the first mile) in April 2013. It must be borne in mind that the usual advertisement of the increase and 14 day consultation period will still apply.
- 3.3 If Members are minded to approve this further increase, the Committee are requested to delegate authority to the Environmental Health Team Manager to adjust the Fare Table with this increase at that time.
