Annex 1 - Mandatory conditions

- 1 No supply of alcohol may be made under the premises licence;
 - a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- Every supply of alcohol must be made or authorised by a person who holds a personal licence.

Annex 2 - Conditions consistent with the Operating Schedule

- A CCTV system shall be maintained which is fit for the purpose. The CCTV system shall incorporate a camera covering the entrance and be capable of providing an image which is regarded as identification standard.
- The CCTV system shall incorporate a recording facility and any recordings will be retained and stored in a suitable and secure manor for a minimum of one calendar month. A system shall be in place to maintain the quality of the recorded image and a complete audit trail maintained.
- The CCTV system shall be maintained and fully operational throughout the hours that the premises are open for the purpose of licensable activities.
- The precise positions of the camera may be agreed with the police from time to time.
- 5 The applicant shall at all times maintain adequate levels of staff. Such staff levels will be disclosed, on request, to the licensing authority and police.
- Adequate waste receptacles for use by customers shall be provided in and immediately outside the premises.
- Signage shall be displayed at the exits of the premises requesting customers leaving the premises late at night to do so quietly and with consideration so as not to disturb nearby residents.
- All staff shall be trained to request evidence of age from any person seeking to buy alcohol and appearing to the member of staff to be under the age of 18. Such evidence is to be of a photographic nature such as a passport or photographic driving licence until other effective identification technology, such as thumbprint or pupil recognition, is introduced.
- 9. The plan which accompanies this application indicates the proposed position for the display and storage of alcohol. Alcohol may be displayed or stored, from time to time, in different positions within the store.

Annex 3 - Conditions attached after a hearing by the licensing authority

No later than 5th March 2008 the licence holder will change the top of the wall at the front of the premises to make it less comfortable to sit on. When the licensing officer is satisfied that the licence holder has complied with this condition, the condition will be removed from the licence.

Licensing Act 2003 - Report to the Licensing Committee regarding the Police application to review the premises licence at Whitwick Service Station and Convenience Store.

Background - why we have made the application:

Sir.

I report in my capacity as the licensing officer for the Leicestershire Constabulary

TWY - Trouble With Youths is the most common heading found on police incidents. Hardly an evening goes by without complaints being received about groups of noisy youths gathering in urban areas.

It is frequently the case that such behaviour is fuelled by alcohol and those that have consumed it are under 18 years of age. This is dangerous drinking because it is unsupervised and such young people do not understand the strength of different alcoholic drinks and the time it takes to have effect. Typically they will drink spirits such as vodka and rum as if they were orange squash or lemonade. Clearly this can have serious health implications and the antisocial behaviour that can result has to be seen to be believed.

Whether the sales to young people are the result of greed or simply through negligence makes no difference – the result is the same - problems for the police, the NHS and the community as a whole.

This unhappy state of affairs has been recognised at Government level resulting in both the police and trading standards officers being encouraged to tackle the problem by mounting test purchase operations.

Here in Leicestershire these operations have been run, since 2002. Sadly the results have been very disappointing with over half the premises visited selling to under age test purchasers.

Where possible premises that have sold have been re-visited in later operations and I am pleased to say, the majority have not re-offended. Unfortunately this premise is in the minority that have sold twice.

Those of us involved in the administration and enforcement of the Licensing Act are well aware of the difficulty in accurately assessing the age of young people.

In order to assist the trade the ACPO and DCMS have promoted the "Challenge 21" approach where staff are instructed to require identification from anyone who appears to be under that age.

There has been a massive amount publicity surrounding this issue in the media. The Leicestershire Constabulary produced over 2000 information packs, which were distributed amongst retail outlets in the County prior to the commencement of the new Act. Information is readily available from the BII, the Portman Group and trading standards departments.

No doubt you have seen signs in supermarkets and elsewhere stating that it is company policy to operate this scheme.

Do you think it would have been possible for these sales to have taken place if the licensee and staff had embraced the challenge 21 policy?

I note the existing licence has a condition which reads:

"All staff are to be trained to request evidence of age from persons seeking to buy alcohol and appearing, to the member of staff, to be under the age of 18 ..."

During the operation which produced the sale on the 14th March 2008 thirty seven premises were visited using the same test purchaser and only two premises sold to her.

The bottom line is that both the Police and the City trading standards department no longer have any confidence in the licence holder's effectiveness in promoting the licensing objectives.

Proposals.

I started this report by referring to the bigger social picture, which provides the background to these particular incidents. The Licensing Act 2003 is a liberalising piece of legislation but it is balanced by providing you with the power to prevent abuses of the law.

Paragraph 11.25 of the Guidance published under Section 182 of the Act states, in relation to reviews,

"There is certain criminal activity that may arise in connection with licensed premises, which the Secretary of State considers should be treated particularly seriously."

There follows a list which includes, "for the purchase and consumption of alcohol by minors which impacts on the health, educational attainment, employment prospects and propensity for crime of young people."

The following paragraph includes, "it is expected that the revocation of the licence – even in the first instance – should be seriously considered."

If you are not minded to take that course of action may I ask you to consider the following:

- 1. The licence be suspended for up to 3 months. This would provide time for the training of staff.
- 2. The removal of the current designated premises supervisor.
- A condition that the licensee will ensure that CCTV is installed following advice from the Leicestershire Constabulary Crime Reduction Officer and maintained in accordance with the Information Commissioner's CCTV Code of Practice. (This can prevent as well as detect crime.)

- 4. A condition that the licensee will adopt the Challenge 21 policy and provide adequate, documented training for staff before they are allowed to serve alcohol.
- 5. A condition that the Designated Premises Supervisor will undertake the BII level one award in Responsible Alcohol Retailing within the next 3 months. This course is recommended by Hazel Blears, the Home Office Minister, as it focuses on the importance of not selling to under age persons.
- 6. A condition that no alcohol will be sold unless the container bears a label identifying the store from which it was sold. This will assist the responsible authorities in identifying the source of recovered alcohol and containers.

I am Police Constable 2005 of the Leicestershire Constabulary, currently based at Coalville Police Station.

I have worked at Coalville Police station since March 2004, initially as a general duty local police officer.

From November 2004 onwards I had been affiliated to the "N24" beat, consisting of Whitwick and Thringstone.

Since February 2007 I have been in the role of the Principal Beat Officer (PBO) for Whitwick and Thringstone.

For the whole time I have been aware of the area, problems associated with young people acting in an anti-social way has been one of the main problems on the beat.

Further investigation into this problem as part of my current role has suggested the consumption of intoxicating substances, particularly alcohol, is one of the main elements of this problem.

To address this element of the problem there have been plain clothes alcohol confiscation patrols operating in the area. When alcohol is confiscated from the young people, they are always questioned about the source of the alcohol they have with them. In addition the parents of the persons involved are spoken to. From the information provided, as well as other community sources, I have been informed by several sources that the young people are currently congregating outside the JET PETROL Station, HKS retail, on TALBOT STREET, WHITWICK, LEICESTERSHIRE. They then ask person over 18 years old to purchase alcohol for them and this is the main source of alcohol for young

alcohol for them and this is the main source of alcohol for young people in the area.

This problem leads to other associated problems such as litter,

vandalism (including arson), trespassing, and more serious criminal offences, as well as complaints of anti-social behaviour through loud noise, abusive language and inconsiderate and offensive behaviour. This is a cause of considerable harassment, alarm and distress to the residents and users of the area and Leicestershire Constabulary are trying to address this problem.

In addition to this indirect selling of alcohol as described, I am also aware of direct sales to under age persons on 2 occasions and alcohol being stolen from the store as well.

I would ask that the store be addressed about this problem at any
