I confirm that I will be attending, we acknowledge the reasons why this application as had to be considered at Committee.





Thank you for your assistance in this matter.



#### To Whom This May Concern

Re: Application for a Premises Licence to be granted under the Licensing Act 2003

We understand that an Engineer's report as been forward to you, who allege that, our CCTV equipment had been deliberately tampered with.

This matter was taken very seriously, with all those members that have access to the equipment being interviewed by the Officials of Coalville RFC, where it was unanimously agreed that these allegations were incorrect.

It was therefore agreed to further investigate this matter, as it was felt that there must be other explanations for the failure of the equipment that had been spoke about by the CCTV Engineer's letter.

We asked an Engineer to investigate and examine the Equipment, to see if he could explain why the system was not working as it should be.

I asked if he would provide us with the outcome of his investigations, of which he gave us a written report of his findings (originally letter enclosed), also what he believes the Club should do, to ensure full confidence in the system that we have in place

The Committee at our meeting held on Wednesday 31<sup>st</sup> March 2010, agreed that we would install a new CCTV System (option 2 in the Engineer's letter), which will be regularly maintained and enclosed in a cabinet, with two individual keys, to be held by two individual Officers of the Club.



To whom this my concern,

I was approached by Pete Smith to look at their cctv system to see if there was a problem with the hard drives or the system itself.

After removing the hard drives from the system and testing them on my computer they seemed to be no problem with the hard drives.

On returning the hard drives back to the cctv system I ran a few tests firstly just to make sure that the hard drives where working fine. After a few days of running the system I checked the hard drives again and find that the 400 gig was working fine but was not cycling on to the 80 gig, I also swaped the hard drives around but the same thing happened again. It would start on the 400 gig and not cycle on to the 80 gig. I checked that the master and slave settings where set correctly on the drives, the 80 gig was set to master and the 400 gig set to slave.(It should always start with master and then cycle on to slave drive)

On further investigation I found out that a new power pack was replaced back in October/November 2009 after it failed due the electricity board doing emergency repairs near the club, This may have spiked the system damaging the hard drive and destroying the power pack in the process.

This would explain why when the power pack was replaced and the unit started working again that everyone assumed it was working ok. So when playback was being used and you watched the video I don't think anyone would notice that the record time in days been reduced.

I understand that the cctv system is checked only when there is an event or when the club opens to the club members and that the system was only added to check for anyone working behind the bar as in the past people have been stealing. So the club installed the system as deterrent.

After testing the cctv system it is my opinion that the club have two options:

- 1. Change both the hard drive and see if this can resolve the problem in terms of recycling.
- 2. Secondly change the system as there may be a fault with the software or hardware after the power supply problem.
