It would be a good thing if everyone objected to the Conti's 3AM application as I really don't think Ashby needs licences that go until 3AM permanently, both clubs have enough temporary events licences to last us throughout the year.

#### SUBJECT: <u>OBJECTION TO VARIATION OF LICENSING HOURS – THE CONTINENTAL MUSIC BAR AND</u> <u>CLUB, 60A MARKET STREET, ASHBY DE LA ZOUCH.</u>

Sergeant Moore.

I make this report, further to my previous one made to you on 8/12/11.

I have trawled through the Leicestershire Police Crime and Intelligence System, and wish to draw the following information to the attention of the Licensing Committee:

From working in the local area and from memory, I believe that the premises under its former names (Arty's and Apollo's) and management, opened around the beginning of 2003, and closed around the end of 2009. During this time, there were a total of 74 separate reported incidents of violence inside or directly outside the premises.

To the best of my knowledge, the Arty's/Apollo's, subsequently closed and remained so, between approximately the end of July 2009, and the beginning of September 2011.

During this time, between 11pm and 8am, at week ends in Ashby town centre, there were a total of 67 reported incidents of Public Order and Assault, and 30 reports of Criminal Damage

I then looked back to when the premises were previously open, and trawled the same period of time, this being from 30/6/2007 - 31/7/2009.

During this time, again at the same times, days, and location stated as above, there were a total of 94 reported incidents of Public Order and Assault, and 44 reports of Criminal Damage.

I think that these figures clearly demonstrate the impact the premises has on the local community.

Since the premises opened around September 2011, (the exact date of which I cannot be certain), under The Continental Music Bar and Club, there have been 4 separate reports of Assault within the premises; and 19 incidents of Public Order and Assault, and 2 of Criminal Damage, within the town centre.

I have produced copies of the figures, which I will bring to the Licensing Hearing for examination by the Committee, if required.
