1. Background

- 1.1 The premises currently operate as a nightclub under the authorisation of a premises licence. The premises licence authorises the sale by retail of alcohol, regulated entertainment and late night refreshment subject to conditions. A copy of the premises licence and conditions is attached as **Appendix 1**.
- 1.2 A map showing the location of the premises is attached as **Appendix 2.**
- 1.3 An application for the variation of premises licence was received from Suzette Elizabeth Lisette Bell-Simmonds 21st December 2011. A copy of the application is attached as **Appendix 3.**
- 1.4 The variation of the premises licence is detailed as follows:

Indoor sporting events, Live music, recorded music, performance of dance, Provision of facilities for dancing, anything of a similar description to live music, recorded music or performances of dance, Provision of facilities for making music, Provision of facilities for entertainment of a similar description to dancing and provision of late night refreshments:

Monday to Wednesday – 09:00hrs until 00:00hrs Thursday – 09:00hrs until 02:30hrs the following morning Friday and Saturdays – 09:00hrs until 03:30hrs the following morning Sundays 12:00hrs until 02:30hrs the following morning

Good Friday, Bank Holiday Sundays and Boxing Day, until 03:00hrs the following morning. From the end of permitted hours on New Years Eve to the start of the permitted hours on New Years Day. An additional hour to the standard and non standard times on the day when British Summertime commences.

Sale of alcohol:

Monday to Wednesday – 09:00hrs until 00:00hrs the following morning Thursday – 09:00hrs until 02:00hrs the following morning Friday and Saturdays – 09:00hrs until 03:00hrs the following morning Sundays 09:00hrs until 02:00hrs the following morning Good Friday, Bank Holiday Sundays and Boxing Day, until 03:00hrs the following morning. From the end of permitted hours on New Years Eve to the start of the permitted hours on New Years Day. An additional hour to the standard and non standard times on the day when British Summertime commences.

Hours premises are open to public:

Monday to Wednesday – 09:00hrs until 00:00hrs the following morning Thursday – 09:00hrs until 02:30hrs the following morning Friday and Saturdays – 09:00hrs until 03:30hrs the following morning Sundays 09:00hrs until 02:30hrs the following morning

Good Friday, Bank Holiday Sundays and Boxing Day, until 03:30hrs the following morning. From the end of permitted hours on New Years Eve to the start of the permitted hours on New Years Day. An additional hour to the standard and non standard times on the day when British Summertime commences.

1.5 The applicant has specified steps they intend to take in order to promote the four licensing objectives:

General – All four licensing objectives:

- The VIP main room hours will remain at 09:00hrs to midnight on Fridays and Saturdays for all licensable activities.
- The premises have operated under their existing conditions inside the Cumulative Impact zone for some time and further conditions are not considered necessary.

2.0 Representations

- 2.1 In respect of an application to vary, the applicant is responsible for advertising the application by way of a notice in specified form at the premises for not less than 28 consecutive days and in a local newspaper. The applicant placed notice in the Ashby Times on 30th December 2011 and officers are satisfied that the correct notices have been displayed at the premises.
- 2.2 The applicant is also required to serve each of the responsible authorities, namely, the Police, Fire Authorities, Trading Standards Department and the District Council's Health and Safety, Environmental Protection and Planning Sections. Officers are satisfied that the applicant has served all parties as required.
- 2.3 A representation has been received from Leicestershire Constabulary on the grounds of crime and disorder, public safety and public nuisance. A copy of the representation is attached as **Appendix 4**.
- 2.4 Interested parties in the vicinity of the premises are able to make representations within 28 days of display of the notice of application to the Licensing Authority. Two representations have been received from interested parties based on crime and disorder, public safety, and the prevention of public nuisance. Copies of the representations are attached as **Appendices 5 & 6.**

3.0 Cumulative Impact

- 3.1 The premises are situated in Market Street, Ashby De La Zouch which is within the area of the special policy on cumulative impact referred to in the Council's Statement of Licensing Policy.
- 3.2 The effect of adopting a special policy of this kind is to create a rebuttable presumption that applications for new premises licences or club premises certificates or variations will normally be refused, following relevant representations, unless the applicant can demonstrate in their operating schedule that there will be no negative cumulative impact on one or more of the licensing objectives.
- 3.3 The Licensing Authority recognises that this policy cannot be absolute and will consider each application properly on its merits and those that are unlikely to contribute to the cumulative impact problems may be approved.

4.0 Statutory Guidance

4.1 In making its decision, the Sub-Committee is obliged to have regard to Guidance issued by the Secretary of State under Section 182 of the Licensing Act 2003. All Licensing Committee members have been provided with a full copy of the guidance document. Officers consider that paragraphs 2.1 to 2.18, 2.19, 2.32 to 2.40, 2.41 to 2.51, 8.5 to 8.11, 8.28 to 8.32, 8.33 to 8.38, and 13.40 to 13.41. may have a bearing upon the application.

5.0 Statement of Licensing Policy

5.1 The Sub-Committee is also obliged to have regard to its own Statement of Licensing Policy. Officers consider that paragraphs 2.1 to 2.11, 3.1 to 3.10, 4.1 to 4.3, 5.1 to 5.3, 6.1, 6.2, 7.1, 7.2, 8.1 to 8.4, 9.1 to 9.3, 10.1 to 10.5, 10.8, 13.1 to 13.2, and 17.1 17.3 may have a bearing upon the application.

6.0 Observations

- 6.1 The Committee is obliged to determine this application with a view to promoting the licensing objectives, which are:
 - the prevention of crime and disorder;
 - the prevention of public nuisance;
 - public safety;
 - the protection of children from harm.
- 6.2 The Committee may take such of the following steps, if any, as it considers necessary for the promotion of the licensing objectives:
 - a) Grant the application as requested.
 - b) Modify the conditions of the licence, by altering or omitting or adding to them.
 - c) Reject the whole or part of the application.
- 6.3 There is a right of appeal to the Magistrates Court against the decision of the Sub-Committee by the applicant and persons who made relevant representations.

Annex 1 – Mandatory conditions

- 1. No supply of alcohol may be made under the premises licence;
 - a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol must be made or authorised by a person who holds a personal licence.

Mandatory conditions coming into force from 6th April 2010:

- 1. (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children-
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
 - (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on-
 - (i) the outcome of a race, competition or other event or process, or
 - (ii) the likelihood of anything occurring or not occurring;
 - (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- 2. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 3. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

Mandatory conditions coming into force from 1st October 2010:

- 1. (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
 - (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 2. The responsible person shall ensure that
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures –
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml; and
 - (b) customers are made aware of the availability of these measures.

Annex 2 – Conditions consistent with the operating schedule

- 1. Prominent, clear notices shall be displayed requesting customers to respect the needs of local residents and leave the premises and the area quietly.
- 2. The licensee shall introduce a policy requiring the production of "proof of age" for any sale that takes place where there is any suspicion that the customer is under 18. Such proof may include a pass conforming to the PASS accreditation system, photo driving licence, student cards and passports.
- 3. The licensee will not introduce or carry on any irresponsible sales promotion or discounting of prices of alcoholic beverages.
- 4. CCTV shall be installed and maintained at the premises in accordance with the ` information commissioners CCTV code of practice.

Annex 3 – Conditions attached after a hearing by the licensing authority


- 1. No bottles or glasses shall be removed from the premises and permitted onto Market Street, North Street, or any other public place.
- 2. The Premises Licence holder shall comply with the Dispersal Policy as agreed by the committee hearing on 15th October 2009 for the premises (see attached).
- 3. The Dispersal Policy shall be made available to interested parties within 7 days upon written request. The Dispersal Policy may be amended from time to time by agreement with the Police Authority.
- 4. The total capacity of the premises shall not exceed 450, comprising 200 for the main VIP room, 100 for the Boudoir Bar, and 150 for Studio 79 located upstairs.
- 5. Noise emanating from the premises as measured at the nearest residential property shall be no more than 5dBA greater than the existing background level.
- 6. During regulated entertainment, all doors and windows shall remain closed except for access, egress and in the case of emergencies.
- 7. Suitable sound attenuation measures shall be maintained in accordance with the premises licence holders noise risk assessments and in consultation with the District Council's Environmental Health Department.
- 8. Acoustic lobbies shall be installed internally to all outside doors.
- 9. During regulated entertainment, regular noise patrols shall be conducted by staff to ensure permitted noise levels are not exceeded.
- 10. A noise limiter shall be installed in conjunction with the District Council's Environmental Health Department.
- 11. Customers using the Boudoir Bar and / or Studio 79 shall enter and exit the premises solely from Market Street except in emergencies.
- 12. The first floor outside terraced area shall be cleared of patrons at midnight.
- 13. All licensable activities shall cease at midnight in the main VIP Room on Fridays and Saturdays.

I refer to the recent application for a variation to the licensing hours at The Queens Head Hotel/Ciro's/VIP Rooms, North Street/79 Market Street, Ashby.

The local police make this representation in line with the NWLDC Saturation Policy, and in relation to three of the licensing objectives, these being Prevention of Crime and Disorder, Public Safety, and Prevention of Public Nuisance.

Our objections are based on the following six points:

- At present, there are approximately fourteen licensed premises within Ashby town centre who serve alcohol. Most of these are open from 11am in the morning, until 11pm, 12 midnight, 1am or 2am. In my opinion, this gives both local people and those visiting the town centre, more than ample time to socialise, drink, and enjoy themselves.
- 2. Due to the amount of licensed premises, people are attracted to the town centre, and the local community has to endure more than its fair share of alcohol fuelled crime, disorder, and Anti-Social Behaviour. There are numerous private dwellings, including OAP complexes, which are occupied in and around the town. On speaking to the local residents, they frequently quite rightly complain about how their life is affected at week ends, due to intoxicated people.

These people subject the local residents to noise, vandalism, theft, litter, and mess, therefore causing them the inconvenience of having to clear up, lack of sleep and general stress.

It is bad enough for them having to suffer these problems until the crowds clear at around 3am, but if the premises were allowed to stay open an hour later, this would have even more of a detrimental affect, with the nuisance not abating until around 4am.

- 3. The licensee will say that the premises are run well, with both good bar and door staff, and I do not dispute this. However, having personally policed Ashby for the best part of seventeen years, I can confirm that when the doors to any licensed premises are closed and locked, there are numerous problems out on the street, with large numbers of intoxicated people, engaging in violence and general ASB.
- 4. Any further extension to the current hours will encourage intoxicated members of the public to gather outside the the applicant's premises, making it a further flashpoint for disorder, which the CCTV operators will have to effectively monitor. This will impact on the monitoring elsewhere.
- 5. The extension of hours may attract more people to the town centre. We must remember that Ashby is only a small market town, and NOT a large city centre which could sustain such changes. I also have it on good authority that if the applicant is successful, then this will set a precedent, and other local licensees will look to apply for the same variation. This can only have an extremely negative affect on the local community as a whole, regarding the issues previously mentioned.
- 6. The demand on police resources to effectively keep both the local community and people using the night time economy safe, is already high. and granting an extension will require additional resources outside the applicants

premises. This will no doubt impact on preventing crime and disorder, and public safety in Ashby, as well as North West Leicestershire as a whole.

Leicestershire Police currently has to make savings of 20% on its annual budget.

To conclude, it is obviously for the applicant to persuade the Licensing Committee that they grant the variation. We have not heard anything from them that will further assist us in preventing crime and disorder, increasing public safety, and preventing public nuisance.

In my opinion, an extension to the licensing hours will further add to the problems we encounter and have to deal with every week end, in Ashby town centre.

On the basis of my points made, I ask that the Licensing Committee refuse this application.

Please accept this e-mail as a letter of objection re the proposed extended operating hours for Ciro's, Queens Head, and VIP Room. Reasons for this objection includes:

- a) increased numbers of people walking about in the middle of the night disrupting sleeping local residents
- b) increased number of intoxicated people wandering the streets with little regard to private property as 'no one is around to see what we are doing' as there is little Police presence at this time
- c) the extended hours will allow patrons the opportunity to 'pull an all nighter' as during the summer daylight would only be 90 minutes away – this would then put early morning dog walker and individuals starting work early at risk of coming into contact with intoxicated individuals
- d) the increase middle of the night disruption to the emotional disturbed residential students at Lewis Charlton School.

Personally, despite apparent music limiters in place, I can still hear music and patrons leaving the clubs despite my hear loss. I am most concerned for my tenants who have normal hearing range and is directly located next to the club through a 9 inch wall. I have had reports from my tenants that on a number of occasions the contains of the flat have vibrated on the walls that required them to contact Lee at the club.

I fear extending the night clubs' operating times would decrease my standard of living. There is no reason for such clubs to operate until these times.

The following views are made on behalf of over 100 members of the Ashby de la Zouch Civic Society.

As you are aware there is an ongoing problem of late night crime and disorder, public nuisance and violence in Ashby de la Zouch town Centre.

This has been contained by the imposition of a special saturation policy for the Town Centre.

We wholeheartedly support this policy which would normally refuse all new licences.

The town council has adopted a policy of opposing late night licenses.

We would conclude on the information available that there is no justification, especially in light of the saturation policy to allow this licence application.

The authority seeks to achieve a balance between leisure and entertainment and the needs of local residents. The key licensing objective of late night licensing is the prevention of crime, disorder and public nuisance.

A late night licence extension for these premises will encourage disorder and antisocial behaviour by concentrating crowds of young people exiting in a residential area.

Experience of Ashby shows that, when young people having consumed alcohol in different pubs, meet in the street, there occurs threatening behaviour, violence and damage to property. These premises would be a focus for these people.

There are several flats and residential houses in this area who would be subject to disturbance and the trading hours allowed should reflect this. The impact on residents in the vicinity of a late licence and people entering and leaving the premises would be disproportionate and unreasonable.

We feel that an extension until 3.30am and 2.30am would cause unreasonable public nuisance and encourage crime and disorder. We are also concerned of the ratcheting of opening hours which is occurring due to competition between clubs. This is confirmed by the attached letter from the owners of Ciros. We would ask you to note that the owners of Ciros consider that current licensing hours are satisfactory. The current differences in closing hours of Ciros and Conti help to stagger the dispersal of customers. We would ask that the Council maintain this stance and maintain the current licensing hours.

We therefore request that this late licence application is refused.
