1.0 BACKGROUND

- 1.1 The premises currently operate as a public house and have the benefit of a premises licence. The premises licence permits licensable activities as specified on the premises licence. A copy of the premises licence is attached as **appendix 1**.
- 1.2 A map showing the location of the premises is attached as **appendix 2.**
- 1.3 An application for the variation of the premises licence was received on the 23rd April 2012 from Stonegate Pub Company Limited. A copy of the application is attached as **appendix 3.**
- 1.4 The variation of licensable activities applied for are:

To extend the terminal hour of licensable activities including films, indoor sporting events, live music, performance of dance anything of a similar description, provision of entertainment facilities for making music, dancing, entertainment of a similar description, provision of late night refreshment and the sale by retail of alcohol.

• Until 02:00hrs on Thursday, Friday, Saturday and Sundays.

To extend the opening time and start time for licensable activities for films indoor sporting events and the sale by retail of alcohol.

From 09:00hrs on Sundays

To permit entertainment of a like kind and facilities for entertainment of a like kind on

Monday to Wednesday
 Thursday to Sunday
 09:00hrs to 01:00hrs
 09:00hrs to 02:00hrs

• Also to include non standard timings as specified on the current licence.

To extend the terminal hour for opening

• Thursday, Friday, Saturday and Sunday to 02:30hrs

To extend the hours for certain non-standard timings as specified on the application

All licensable activities to 03:00hrs

To extend an additional hour

• On standard and non-standard times on the day when British Summertime commences

To remove a condition

- Text or radio pagers shall be used during the hours of 12:00 midnight and 01:00hrs the following morning and Thursday and Sundays.
- 1.5 The applicant has specified that considering the proposed variation they do not feel further steps will be necessary to promote the licensing objectives.

2.0 REPRESENTATIONS

- 2.1 In respect of a new application, the applicant is responsible for advertising the application by way of a notice in specified form at the premises for not less than 28 consecutive days and in a local newspaper. The applicant placed notice in the Ashby Times on 27th April 2012 and Officers are satisfied that the correct notices have been displayed at the premises.
- 2.2 The applicant is also required to serve each of the responsible authorities, namely, the Police, Fire Authorities, Trading Standards Department and the District Council's Health and Safety, Environmental Protection and Planning Sections. Officers are satisfied that the applicant has served all parties as required and two representations have been received from the Leicestershire Constabulary and Environmental Protection and these representation and supporting documents are attached as appendices 4 and 5.
- 2.3 Interested parties in the vicinity of the premises are able to make representations within 28 days of display of the notice of application to the Licensing Authority. No representations have been received from interested parties.

3.0 STATUTORY GUIDANCE

- 3.1 The application for a premises licence was received prior to the change of legislation on 25th April 2012 and therefore the October 2010 edition of the guidance issued under section 182 of the Licensing Act 2003 should be used.
- In making its decision, the Sub-Committee is obliged to have regard to Guidance issued by the Secretary of State under Section 182 of the Licensing Act 2003. All Licensing Committee members have been provided with a full copy of the guidance document. Officers consider that paragraphs 1.17 to 1.19, 2.1 to 2.18, 2.19 to 2.31, 2.32 to 2.40, 8.46 to 8.50, 8.77 to 8.80 8.81 to 8.84, 8.85 to 8.94, 9.3 to 9.7, 9.19 to 9.28 may have a bearing upon the application.

4.0 STATEMENT OF LICENSING POLICY

4.1 The Sub-Committee is also obliged to have regard to its own Statement of Licensing Policy. Officers consider that paragraphs 2.1 to 2.6, 5.1, 6.1, 7.1, 7.2, 8.1, 8.2, 8.3, 8.7, 9.1 to 9.3 and 17.1 to 17.3 may have a bearing upon the application.

5.0 OBSERVATIONS

- 5.1 The Committee is obliged to determine this application with a view to promoting the licensing objectives, which are:
 - the prevention of crime and disorder;
 - the prevention of public nuisance;
 - public safety;
 - the protection of children from harm.
- 5.2 The Committee may take the following steps, if any, as it considers necessary for the promotion of the licensing objectives:
 - a) Grant the application as requested.
 - b) Modify the conditions of the licence, by altering or omitting or adding to them.
 - c) Reject the whole of part of the application.
- 5.3 There is a right of appeal to the Magistrates Court against the decision of the Sub-Committee by the applicant, premises licence holder and persons who made relevant representations.

Annex 1 - Mandatory conditions

- 1. No supply of alcohol may be made under the premises licence;
 - a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol must be made or authorised by a person who holds a personal licence.
- 3. The admission of children to the exhibition of any film is to be restricted in accordance with these conditions and Section 20 of the Licensing Act 2003.
- 4. Where the film classification body is specified in the licence, unless condition 5(b) applies, admission of children must be restricted in accordance with any recommendation made by that body.
- 5. Where-
 - (a) the film classification body is not specified in the licence, or
 - (b) the relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question,

admission of children must be restricted in accordance with any recommendation made by that licensing authority.

- 6. In this section-
 - "children" means persons aged under 18; and
 - "film classification body" means the person or persons designated as the authority under section 4 of the Video Recordings Act 1984 (c.39) (authority to determine suitability of video works for classification).
- 7. The permitted hours stated above for the sale of alcohol do not prohibit:
 - a) Consumption of the alcohol on the premises or the taking of sale or supply of alcohol to any person residing in the licensed premises;
 - b) The ordering of alcohol to be consumed off the premises, or the despatch by the vendor of the alcohol so ordered:
 - c) The sale of alcohol to a trader or club for the purposes of the trade or club;
 - d) The sale or supply of alcohol to any canteen or mess, being a canteen in which the sale or supply of alcohol is carried out under the authority of the Secretary of State or an authorised mess of members of Her Majesty's naval, military or air forces;
 - e) The taking of alcohol from the premises by a person residing there; or
 - f) The supply of alcohol for consumption on the premises to any private friends of a person residing there who are bona fide entertained by him at his own expense, or the consumption of alcohol by persons so supplied; or
 - g) The supply of alcohol for consumption on the premises to persons employed there for the purposes of the business carried on by the holder of the licence, or the consumption of liquor so supplied, if the liquor is supplied at the expense of their employer or of the person carrying on or in charge of the business on the premises.

8. In relation to the morning on which summer time begins, the permitted hours for the sale of alcohol shall have effect with the substitution of references to three o'clock in the morning for references to two o'clock in the morning or one hour following the hour specified where the hour is between 1am and 2am.

Mandatory conditions coming into force from 6th April 2010:

- (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children—
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to—
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
 - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less:
 - (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on—
 - (i) the outcome of a race, competition or other event or process, or
 - (ii) the likelihood of anything occurring or not occurring;
 - (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- 2. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 3. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.

Mandatory conditions coming into force from 1st October 2010:

- 1. (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
 - (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 2. The responsible person shall ensure that --
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml; and
 - (b) customers are made aware of the availability of these measures.

Annex 2 - Conditions consistent with the operating schedule

- 1. 14 days written notice shall be given to the Leicestershire Constabulary prior to the premises opening outside the permitted hours for licensable activities for the transmission of a recognised international sporting event. The event will not proceed if the Police serve, 7 days prior to the event, written notice upon the designated premises supervisor.
- 2. The licensee shall monitor the need for door supervisors and in doing so take into account any advice given by the Leicestershire Constabulary.
- 3. The premises manager shall actively participate in the local PubWatch scheme whilst such scheme exists.
- 4. Text or radio pagers shall be used during the hours of 12.00 midnight and 1.00am the following morning on Thursdays and Sundays.
- 5 All pint and half pint glasses used at the premises shall be toughened glass.
- 6. CCTV shall be provided and maintained at the premises.
- 7. The licensee shall not introduce or carry on any promotions of alcoholic beverages that encourage illegal, irresponsible or immoderate consumption.
- 8. The licensee shall take reasonable steps to recognise the rights of local residents and to encourage customers to leave the premises quietly.
- 9. Premise managers shall liase with local neighbours as part of their duties and resolve any reasonable concerns.
- 10. The premise manager and staff shall be briefed in the importance of their responsibilities in ensuring that customers are over 18 years of age.
- 11. The licensee shall operate a policy requiring proof of age for any sale where there is any suspicion that the customer is under 21 years of age.
- 12. The licensee shall display suitable notices advising customers of the policy referred to at condition 10 above.
- 13. The capacity, including those employed in the premises, shall not exceed 360.



As an addition to our objections against the variation of licensing hours for the Bulls Head PH situated at 67 Market Street Ashby I have the following to report.

Details at the end of this report demonstrate that CCTV monitoring appears to record a significantly higher number of incidents occurring *in Market Street* than those actually reported to the Police.

While it may be legitimately argued that a lot of these incidents outlined do not actually occur in the Bulls head PH they evidence significantly demonstrates to the licensing committee that the vast majority do occur <u>in or around</u> the applicant's location in Market Street. All directly impact on crime and disorder, public nuisance and safety.

Licensing law was never intended to be used a mechanism for the general control of antisocial behaviour by individuals once they are beyond the direct control of the individual business holding the licence.

However the Licensing Authority expects every holder of a licence to be responsible for minimizing the impact of the activities aligned to the licensing objectives and anti-social behaviour by patrons within the immediate vicinity of their own premise. It also requires licence holders to demonstrate that they have taken appropriate action.

This application fails to demonstrate any of the above criteria and seems reliant of the fact they have considered the potential but do not feel there will be a problem if the application is granted.

In terms of CCTV log operators are required to record in their log book what is being viewed. Material footage is only retained for a period of 30 days and is then over written. Initially while preparing this report I looked at x6 days in the December 2011 chosen because they represented temporary event notices concerning another licensed premise within the saturation zone that had sought to increase its hours. This application was rejected by the committee.

I did increase the period to include all CCTV logged incidents occurring in Market Street Ashby up to the 18th March 2012 (18th of March was chosen as an end date simply because I have not had access to material after this date in preparing my report and for no other reason).

I only included incidents recorded in Market Street and the initial six days used represent 9th, 16th and 23rd of December which fell on Friday evenings while one covered the 25th which was a Sunday and the other covered the 31st which represented a Saturday.

The Bulls Head seeks to increase their opening hours between Thursday and Saturdays until 2.30am so the above days represent an important consideration.

From the 9th December until the 18th March a total of 92 incidents were recorded in Market Street and are documented in the CCTV operator's log. (A copy is attached in our opposition bundle). The dates and incidents within the log were then compared to actual times and dates on Leicestershire Constabularies Forces incident reporting system.

Almost all of those logged entries involve disorderly behaviour, collapse, drunkenness or assault and clearly do not support the primary licensing objectives with only x7 of these documented log entries occurring after midnight actually correlating to Police reports.

Delving further into this information x7 recorded incidents in 92 logged reports amounts to only 7.6% of the total number of incidents <u>actually reported to Police</u> during the specified period.

This demonstrates that over 92% of incidents actually viewed by CCTV operators go unreported to the Police. A significant number of these occur in Market Street as opposed to linking directly with licensed premises. At the conclusion of this report are details of these log entries that correlate to reported incidents we have on our systems but only include those occurring after midnight.

There were a further x9 incidents reported to Police (marked) at the end of this report that all occurred after midnight during the same time frame. These incidents relate to matters managed by Police and are <u>additional to those actually documented</u> by the operator reflecting that Police actually deal with considerably higher numbers of incidents linked to alcohol consumption and NTE in Ashby than those actually reported.

Increasing the Bulls Head licensable hours will only add to the increasing problems faced by officers in managing crime and disorder within Ashby.

It is obvious and apparent based by what has been presented that there are a significantly higher number of incidents involving Crime and Disorder, Public safety and Nuisance occurring in Market Street in or around the Bulls Head public house that go unreported.

I believe that any extension to licensing hours for the Bulls Head public house will simply increase and directly impact against the licensing objectives and it is for this reason I urge the committee to refuse this application.

Sir

The purpose of this document is to highlight the type of incidents dealt with as a direct result of current licensing hours in force in Ashby De La Zouch. They reveal a picture to the Licensing Committee of unruly behaviour that significant contributes to Crime & Disorder, Public Nuisance and against Public Safety and range from Criminal Damage, Assaults, Theft, Indecent Exposure, & Violent Public order offences that have occurred inside licensed premises and in particular Market Street in close proximity to the applicants premise.

The information only includes detail concerning Market Street as opposed to other areas within the "Cumulative Impact area" included in NWLDC licensing policy.

I selected 8 days per calendar month covering Friday & Saturday evenings between the hours of 11pm-8am during a 12 months period equalling 4 weekends a per month less Sundays.

Below are the details of incidents recorded on Leicestershire's Crime Intelligence System as opposed to those recorded on Leicestershire's dispatch system which is the system where calls are taken and recorded during these periods but may not necessarily require a crime record creation.

January 2011 (x9 Incidents)

February 2011 (x7 Incidents)

March 2011 (x8 Incidents)

April 2011 (x3 Incidents)

May 2011 (x4 Incidents)

June 2011 (x6 Incidents)

July 2011 (x2 Incidents)

During this period there were a total of 59 reported crimes and of those 33 crimes representing a figure of 55% occurred in Market Street *in or around* the applicants premise. 2 of the 33 crimes occurred in the Bulls Head.

55% is a huge contributory factor to Crime and Disorder, Public Nuisance and Public Safety given that the applicants premises sites within the fray of these problems and also within the cumulative impact area of Ashby.

It is worth noting that 88% of the total recorded crimes occurred after midnight and this application seeks to extend licensing hours well into the morning.

Agreeing to this variation of hours will certainly risk increasing this type of crimes which impacts on public safety & nuisance associated with alcohol consumption.

Further documentary evidence submitted by way of NWLDC (CCTV Logs) reflects that an even larger proportion of crime and disorder in Market Street already goes unreported to the police which further undermines the licensing objectives and presents a disturbing picture of alcohol fuelled violent behaviour.

The CCTV detail is contained within a separate report by me (see 'Bulls Head & CCTV Log Incidents').

SUBJECT: Opposition to Bulls Head extension of licensing hours

Sir,

I refer to the recent application for the Bulls Head public house situated at 67 Market Street Ashby de la Zouch Leicestershire.

The applicant seeks to increase its current licensing hours by extending them until 2.30am Thurs – Saturday including the terminal hour and for certain non standard other licensable activates until 3am. Additionally the applicant also seeks to increase trading hours a further 1 hour period to cover BST change over.

Our opposition to this application for variation of license is based on the principles of licensing law paying specific regard to: The Prevention of Crime and Disorder, Promotion of Public Safety, Preventing Public Nuisance and Preventing Harm to Children.

There are currently 72 licensed premises in Ashby 19 of these are already operating within the cumulative impact zone as identified by the special provision within the NWLDC statement of licensing.

The Bulls Head is situated within a very popular location of Ashby Town and enjoys a large volume of clientele. It sits within a minute's walk of several late night refreshment houses and is located almost directly opposite and adjacent to other busy licensed premises.

It is within a 30 second walk of a vibrant nightclub where it can be shown that a significant proportion of Crime and Disorder, Public Nuisance and public safety issues have already occurred.

Many of the licensed premises near the Bulls Head currently serve alcohol and remain open from 11am in the morning until 1am or 2.30am. This provides ample opportunity for locals or visitors to Ashby plenty of opportunities to socialise, drink, and entertain without the need for extended licensing hours.

Increasing licensing hours at the end of the evening simply encourages large croups of people to pour into the street and either loiter near fast food outlets or visit other licensed premises and continue to consume more alcohol. This behaviour often and routinely results in sporadic flash points for crime and disorder, nuisance and public safety.

Our representations are made in line with and support the NWLDC statement of licensing policy drawing particular reference to the cumulative Impact (saturation zone) and in respect of three of the aforementioned licensing objectives.

There are already significant risks of violence (i.e. crime) and anti-social behaviour (i.e. disorder) as well as Nuisance in the locality of this premise as outlined in our complaint objection.

If the licensing committee were to grant this application I believe that they would be failing to carefully consider paragraphs 3.15 of their own statement of licensing policy in specific regard to the cumulative impact which places the onus on the applicant to demonstrate that any variation to hours will not impinge on the licensing objectives

At present we have seen nothing from them that warrant this application or support any justification to vary their current licensing hours.

While Police routinely patrol Market Street in Ashby town in order to prevent or minimise potential for drink related violence associated to disorder I have demonstrated in additional documents submitted to this committee there are many incidents occurring in or around the vicinity of the Bulls head (Market Street). All of these impact against the primary licensing objectives and range from fights and skirmishes in to assaults and violent public order.

Members of the public should be afforded a degree of protection from hostility and nuisance while socialising in Ashby. However by granting this application it will merely encourage others to drink for longer periods and loiter or congregate thereby increasing the risks of alcohol related violent confrontations.

Longer drinking hours incites discord that almost always terminates in fights after closing hours. Innocent parties are subjected to abuse and nasty assaults and this mindless drunken mentality is catalyst for significant flash points of violence associated with crime and disorder and anti social behaviour.

Alcohol consumption and disorder is extremely topical at present and as such further measures including the PRSR Act 2011 (Police Reform and Social Responsibility Act) have been introduced by the Government.

It is worth noting that this legislation was introduced to tackle and drive down alcohol fuelled Crime and Disorder, Nuisance and Public Safety linked to N.T.E (night time economy) and is part of a strategy designed to improve our communities.

The councils own CCTV operators have recorded significant increases of crime and disorder that already goes unreported to the Police and I have outlined these in an additional report. (See report Bulls Head CCTV log).

I have 25 years service in Leicestershire Constabulary all of which has been undertaken as a front line operational Police officer. I have been a Sergeant since 1994 representing 18yrs in this rank. From 2007 until the end of 2009 I was the Sergeant responsible for all licensing matters in Loughborough Town centre and the night time economy within this area. I also hold the British Institute of Innkeepers NCPLH certificate as a qualification and during my service I have worked in all areas of Leicester City and most of the county covering public order linked to N.T.E.

I can say that where licensing hours are increased particularly where there are saturations zones in force increases Crime and Disorder, Public Nuisance and ASB increase.

Concentrations of young drinkers leaving clubs in order to purchase food or obtain lifts home results in queues which in turn leads to conflict, disorder and anti-social behaviour. While more flexible licensing hours may well reduce this impact and allow a more gradual dispersal of customers, increasing this premise (Bulls Head) licence hours will have the opposite effect and creates concentrations of individuals likely to cause disorder, damage and nuisance affecting others safety.

Nearby shop entrances are often used as urinals by both sexes. Vomit and urine can be seen in the streets and on the pavements well after these premises have closed which promotes Public Nuisance and Public Safety.

I am deeply disturbed that the impact of increasing licensing hours for this premise will promotes the problems aligned to the licensing objectives and the applicant has not demonstrated in any way how they will rebut this.

It is my belief that the extension to this clubs licensing hours will increase crime & disorder, public nuisance and public Safety and it is on this basis I submit this report for your considered attention and seek the licensing committee refuse the application.
