1.0 BACKGROUND

- 2.3 The results of the questionnaire will be used by the West Leicestershire Clinical Commissioning Group to inform a further consultation on the Community Hospitals likely to be held in the autumn.

West Leicestershire community hospitals: the way forward

What are we doing?

West Leicestershire Clinical Commissioning Group (CCG) was formed out of a consultative collaboration of local GPs across four localities. We have from the outset had some common principles in how we should work. One was to listen to the views of "patients, practices and partners" on the services we commission: the other being to make the most of our rather unusual situation of having five community hospitals in the patch. We have Loughborough Hospital, Ashby and District Hospital, Coalville Community Hospital, Hinckley and District Hospital, and Hinckley and Bosworth Community Hospital.

This provides us with a unique opportunity to provide more services closer to home, but also the challenge of making sure these services offer good value for money.

So we have begun a comprehensive review of the services currently provided at these hospitals, and how best the hospitals can be used in the future.

What are the challenges?

WLCCG need to carry out this programme of work now because:

1. We need to meet the changing health needs of the population

The population of Leicestershire is predicted to grow by over 10% in the next 15 years. By 2033 a quarter of the population of Leicestershire will be over 65. It is great news that people are living longer but they also develop more chronic illness, which needs to be cared for.

So the future sees a larger proportion of older people, who will also (quite rightly) have higher expectations of the sort of care they receive. Patients want more choices, and more services provided locally. They also want more say in decisions made about their management. Many patients want to be more in control of managing their own chronic illness.





Our early surveys of patients also indicate they have concerns about current standards of care for the elderly, and services they receive in hospitals.

All of this will place a significant challenge to our community services, and particularly our community hospitals. We need to act now to ensure that they are prepared for this change and can continue to provide the care that our patients require and expect.

2. We need to ensure the community hospitals are fit for purpose, addressing both the poor condition of parts of the existing estate, and the current under utilisation of the hospitals

In January 2009, in the wake of a previous community hospital review, the previous commissioner, Leicestershire County and Rutland Primary Care Trust (PCT), approved a tenyear vision for community services. The vision set an agenda to meet the challenges that had been identified surrounding the current community hospitals, specifically that:

- The hospitals were underutilised, with not enough care being delivered in the community setting.
- There was an overdependence on secondary care which was acting as a barrier to achieving the local vision that care be delivered closer to home.
- The delivery of high quality care from some elements of the existing poorer estate was not sustainable in the long term.

These issues remain relevant today and we need to use the opportunity we have now that GPs are commissioning services to resolve these once and for all.

3. We need to ensure that community hospitals are delivering value for money

Whilst the Government has committed to increasing the NHS budget in cash terms, the NHS still faces significant financial pressures.

Building upon its success in 2011/12, the CCG is aiming to deliver $\mathfrak{L}7.14$ million QIPP saving but will additionally invest $\mathfrak{L}2.3m$ of development funds and $\mathfrak{L}7.1m$ of transformation funds directly towards delivering against the key transformation priorities.

One of these priorities is to make sure that community hospitals are an effective use of public money.





4. Consider the commissioning intentions of our neighbouring CCGs, and the impact of changes occurring at University Hospitals of Leicester

One of our key priorities as an organisation is that we engage fully with our local partners to gain the maximum possible involvement and agree a shared local vision, in developing local health services. Although we are three separate CCGs changes in services provided in one area will often impact on those in another.

What will happen next?

The programme began in June and will run through to September. During this period we will:

- Work with GP colleagues to prioritise local concerns and health needs.
- Work with partners in our community and acute hospitals, social care and other community services to create an integrated system.
- Use clinical best practice to ensure that we are not restricting ourselves to current ways of working and are developing the best possible health system for our communities.
- Learn from our past experiences with our community hospitals to ensure their rich history in West Leicestershire is reflected in any decisions we make.

Also, it may not always be possible, due to the need for specialist staff and expensive equipment to have all diagnostic tests (for example, certain scans and specialised x rays) delivered in community settings.
