## 1. Background

- 1.1. On 3 August 2021, Liluben Odedra submitted an application for a premises licence grant at The Spar, Delven Lane, Castle Donington, Derby DE74 2LJ. A copy of the application is presented as **Appendix 1**. A plan of the premises is presented as **Appendix 2**.
- 1.2. An aerial view of the site is presented as **Appendix 3** and a map is presented as **Appendix 4**.

1.3. The application identifies that if the premises licence variation is granted, the following opening hours and licensable activities will occur.

Opening Hours	Timings	
	Everyday	07:00 hours - 22:00 hours
Licensable activity	Timings	
Supply by retail alcohol	of Everyday	07:00 hours - 22:00 hours

1.4. As part of the application, the applicant has specified the steps they intend to take in order to promote the four licensing objectives. These are as follows:-

#### General

All licensing objectives will be met and the business will undertake all responsibilities under the Licence Act 2003.

## The prevention of crime and disorder

28 days cctv recording to be kept and can be viewed by officers.

Posters of Challenge 25 and 'no id no sale' will be displayed throughout the shop. Staff will be trained appropriately.

Refusals log register will be kept.

#### Public safety

All due diligence to be kept when keeping customers safe from harm. Floors will be clear from hazards.

#### The prevention of public nuisance

Refuse collection will be between 07:00 and 18:00.

#### The protection of children from harm

Children under 18 will not be allowed to purchase alcohol.

Third party sales will not be permitted.

'No id no sale' poster will be on display at point of purchase.

1.5 The premises are not currently trading and therefore the licensing authority have not received any complaints in relation to the premises.

## 2 Representations

- 2.1. In respect of an application for the grant of a premises licence, the applicant is responsible for advertising the application by way of a notice in specified form at the premises for not less than 28 consecutive days and in a local newspaper. The applicant placed a notice in the Loughborough Echo on Wednesday 11 August 2021 and officers are satisfied that the correct notices have been displayed at the premises.
- 2.2 Each of the responsible authorities have been served a copy of the application, namely; the Police, Fire Authorities, Home Office, Trading Standards Department, the District Council's Health and Safety, Environmental Protection, Public Health Authority and Planning Sections. We have received no representations from the responsible authorities.
- 2.3 One relevant representation has been received from a member of the public on the grounds of prevention of crime and disorder, prevention of public nuisance and public safety. This representation is presented as **Appendix 5.**
- 2.4 Two further representations were received from members of the public which were deemed to be "irrelevant" and were rejected. These representations are presented as Appendices 6 8. The acknowledgement and rejection letters are presented as Appendices 9 and 10.

### 3. Statutory Guidance

3.1 In making its decision, the Sub-Committee is obliged to have regard to Guidance issued by the Secretary of State under Section 182 of the Licensing Act 2003. All Licensing Committee members have been provided with a full copy of the guidance document. Officers consider that paragraphs 1.1 to 1.5, 1.13 to 1.17, 2.1 to 2.6, 2.7 to 2.9, 2.15 to 2.21, 2.22 to 2.31, 3.1 to 3.2, 8.13 to 8.14, 8.34, 8.41 to 8.49, 8.80 to 8.87, 9.1, 9.3 to 9.9, 9.31 to 9.44, 10.1 to 10.10, 10.13 to 10.15, 13.10, 14.1 to 14.3, may have a bearing upon the application.

## 4. Statement of Licensing Policy

4.1 The Sub-Committee is also obliged to have regard to its own Statement of Licensing Policy. Officers consider that paragraphs 2.1 to 2.5, 3.0, 4.1 to 4.4, 5.1 to 5.4, 6.1 to 6.4, 7.1 to 7.4, 11.0, 19.2, 22.0, 23.0, and 26.0 may have a bearing upon the application.

#### 5. Observations

- 5.1 The Committee is obliged to determine this application with a view to promoting the licensing objectives, which are:
  - a. The prevention of crime and disorder;
  - b. Public safety:
  - c. The prevention of public nuisance;
  - d. The protection of children from harm.

- 5.2 The Committee may take such of the following steps, if any, as it considers appropriate for the promotion of the licensing objectives:
  - Grant the application and issue the premises licence as requested.
  - Modify the conditions of the licence, by altering or omitting or adding to them.
  - Reject the whole or part of the application.
- 5.3 There is a right of appeal to the Magistrates' Court against the decision of the Sub-Committee by the applicant and persons who made relevant representations.

- Live music: no licence permission is required for:
  - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
  - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
  - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.





I am Chairman of Castle Donington Town Bowls Club whose premises are adjacent to the ex Library, now apparently a Spar shop.

I note the notice advising of the application for a Premises Licence and wish to register my objections on behalf of the Bowls Club.

Firstly we have not, as neighbours, received any planning notice nor have seen a planning notice displayed at the premises, advising an application for change of use from a Library to a Shop and therefore conclude that the premises are still a Library. This being so I object to a Library selling alcohol.

Secondly, we already suffer litter from the younger elements of the area using our car park as a dining area and leaving behind their litter. Should a shop be approved and granted an alcohol Premises Licence this can only compound our current problems.

We are not able to fence off and gate our car park as the Territorial Army use the hut accessed through our car park and we in turn have access rights across the vetinary hospital car park so they cannot gate their car park as they have to give us and the T A access.

The village already has five shops selling alcohol, will soon have a sixth as well as a variety of food outlets that sell alcohol and a multiplicity of public houses, hotels and clubs, so an additional alcohol selling outlet is simply not required.

I trust this application will be refused.

- 1. We understand the premises is a Library and is registered under use class F1 d. We are of the view that the sale of alcohol within a library is not in the publics best interests and there will be a high risk of public nuisance. Such a license will not be suitable for such a setting especially where minors are likely to attend.
- 2. In the event the license is granted, we are concerned there will be an influx of intoxicated individuals making use of the surrounding parking and driving vehicles while intoxicated, and therefore causing a risk to public safety, especially to our staff and clients.
- 3. Individuals will have to park on the Road or pavement to access the library; this will cause a public safety issue.

Thank you for your e-mail and representation concerning the above application. Please accept this letter as acknowledgement of your representation. Unfortunately, in this instance, your representation is not considered relevant and is therefore rejected. The reason for rejection is as follows:-

We understand the premises is a Library and is registered under use class F1 d. We are of the view that the sale of alcohol within a library is not in the publics best interests and there will be a high risk of public nuisance. Such a license will not be suitable for such a setting especially where minors are likely to attend.

All Planning issues are dealt with under the Town and Country Planning Act 1990 and not under the Licensing Act, so this is not relevant with regard to this application. However the premises was a library. It is not a library anymore. I understand the applicant has been in touch with the planning department and an application is being submitted. Of course they will have to change the planning permissions to operate as a shop. However this has nothing to do with this application or the licensing act objectives, so it would not concern this application. I can confirm the sale of alcohol will not take place within a library, where minors are likely to attend.

In the event the license is granted, we are concerned there will be an influx of intoxicated individuals making use of the surrounding parking and driving vehicles while intoxicated, and therefore causing a risk to public safety, especially to our staff and clients. Individuals will have to park on the Road or pavement to access the library; this will cause a public safety issue.

Parking issues are covered under the Highways Act 1980 and are not a matter for the Licensing Act, this is therefore not relevant with regard to this application. If you wish to discuss parking issues, please contact Highways at Leicestershire County Council

The alcohol licence would increase the number of intoxicated individuals and therefore result in a risk of the hospital being broken into as there are dangerous drugs being stored on site. This is a risk of harm to the public and the cause of public nuisance.

The application is for a shop with "off-sales" only and not for a bar with "on sales". Therefore it is highly unlikely there will be "increased numbers of intoxicated individuals" in the area due to a shop opening. We also have numerous veterinary surgeons within the North West Leicestershire District which are close to shops and bars and I am not aware of these veterinary hospitals being broken into by intoxicated individuals, as a result of having a local shop selling alcohol.

As a result, this representation cannot be considered as relevant, as there is no evidence of "cause to public safety", "an increased number in intoxicated people", "public nuisance" or "break-ins at veterinary hospitals". However, should you have evidence of cause to public safety, an increase in intoxicated people, public nuisance or break-ins into your hospital, please feel free to submit a further representation with this evidence attached (before the end of representations deadline on 31 August 2021) and it will be given it every consideration by the licensing Sub-Committee.

Should the licence be issued and as a result, the issues you mention above do materialise, there is an option within the Licensing Act for you to call a review of the licence. If there is evidence of these issues demonstrated at the review, the licence could be revoked or amended, so there are measures in place going forward within the Licensing Act. However at this stage, the issues you mention are merely speculation of a worse-case scenarios and cannot be considered, as they may never occur.

However, should you have evidence with regard to this premises and with regard to the Licensing Act's 4 objectives, please feel free to submit a further representation with this evidence attached (before the end of representations deadline on 31 August 2021) and it will be given it every consideration by the licensing Sub-Committee.

Should the licence be issued and as a result, any issues do materialise, there is an option within the Licensing Act for you to call a review of the licence. If there is evidence of these issues demonstrated at the review, the licence could be revoked or amended, so there are measures in place going forward within the Licensing Act. However at this stage, the issues you mention cannot be considered.
