These premises are in a densely populated residential area, on the edge of the town centre. With residential properties in very close proximity.

On the 4<sup>th</sup> December 2013 Mr Nicholas Garbett became the DPS for the premises and the following day he also became the Premises Licence Holder.

Licensing visits from April 2013 have identified that Mr Garbett was linked to the premises as a manager at this time, although he had no personal licence.

The Police Inn Webb computer system is a data base recording all visits and interactions between the police and the premises. Briefly:-

2010 - No visits reports

2011-2 Visits (test purchase failure and report of noise)

2012-4 visits (report of drugs, noise)

2013-19 visits/interactions

2014-12 visits/interactions

- 1. 29<sup>th</sup> March 2014
- 22.10 hours, failure of test purchase. Member of staff sells bottle of Budweiser to 14 year old. (currently under consideration of prosecution)
- 2. 14-15<sup>th</sup> March 2014

  Noise complaints to NWLDC. DPS agrees to turn down juke box after 21.00 hours.
- 3. 23<sup>rd</sup> February 2014 Crime ref LN/88314-5, DPS arrested for affray, whilst drunk in Ashby. Cautioned.
- 4. 23<sup>rd</sup> February 2014

LN/880/14-6 refers. 01.50 hours, 12 males fighting in the street having just left the Three Crowns. Initial accounts state the incident started in the premises and spilled out into the street.

CCTV was requested at the time but DPS not present (see above), 3 further requests made for the CCTV which were unsuccessful. CCTV finally produced on 2<sup>nd</sup> March; however this does not appear to work.

5. 7<sup>th</sup> December 2013

Test purchase carried out, no sale made.

6. 30<sup>th</sup> November 2013

Formal interview with DPS and action plan created, following incidents of 24<sup>th</sup> and 16<sup>th</sup> November. Action plan attached

7. 30<sup>th</sup> November 2013

Crime LN/6343/13-9 refers, offender arrested for assault and criminal damage at girlfriends home, having just left the Three Crowns. Witness states that the suspect was so drunk in the pub he could hardly stand or talk. He was walking around the premises with drink and spilling it as he was walking, he was so drunk. Offender charged with damage and assault.

8. Sentinel (Police ASB database) 29<sup>th</sup> November 2013 Report of noise from the premises. Community consultation reports fighting in the street at 01.00 hours, shouting, urinating up walls, taxi's coming and going with doors slamming. Noise and music from the beer garden. Residents complain of noise on Thursday to Sunday evenings. Noise to as late as 02.30 hours. The residents complain of premises still open at 02.30am with music emanating from premises.

9. Sunday 24th November 2013

2 am, Pc 819 Harrison and Pc 2925 Broomfield will provide statements that they observed that the premises was still playing music and people were leaving at 2.30 am in breach of Premises Licence.

10. Friday 22<sup>nd</sup> November 2013

Licensing visit by Sgt Watson. Request was made to Mr Garbett for CCTV of the incident on 16<sup>th</sup> November 2013; he was unable to burn a copy on request. Mr Garbett stated he was the DPS (records show a Mr. Wallace as DPS). No premises licence displayed.

11. Saturday 16<sup>th</sup> November 2013

LN/6116/13-2 and LN/6533/13-9 refer to two serious assaults on customers of the Three Crowns as they leave the premises at 3.10 hours, requiring referral to the LRI. All persons involver were drunk and had come from the premises. One of the persons involved admitted to receiving free drinks.

Mr Garbett admitted to officers that he had given away free drinks during the evening.

CCTV was requested and Mr Garbett was reluctant to assist officers, requiring the intervention of a senior police officer to allow officers to view the footage. Only three cameras were working and Mr Garbett did not know how to burn the images to disc.

Since the premises has been associated with the current Premises Licence holder there has been a number of complaints received by the police with regard to anti social behaviour, drinking outside licensing hours, drug use, excessive noise and assaults. These have been brought to the attention of the PLH/DPS yet these incidents continue to be reported. Statements from local residents are attached.

The action plan agreed by Mr Garbett and Sgt Watson on 30<sup>th</sup> November 2013 for a period of 6 months has only been implemented over the Christmas period.

Leicestershire Police therefore have no confidence in the present management regime at the Three Crowns.

It is the police view that all four licensing objectives are being undermined by the PLH/DPS Mr Garbett.

It is the police view that given all the circumstances, that the promotion of the licensing objectives is best served with revocation of the premises licence.

Whilst I do not wish to restrict the decision of the committee, they may wish to consider the following as a measure to address the concerns raised by the police and the community:

- a. Amend the licence to terminate all licensable activity by 23.00 (Mon Thurs), 23.30 (Fri-Sun) with the premises to close by midnight.
- b. Remove public entertainment as a licensable activity
- c. The removal of the current DPS
- d. The warning of the premises licence holder that any further undermining of the licensing objectives will, in all probability, result in revocation of the licence.
