<b>To prevent crime and disorder</b>	An increase in the frequency and length of the sale of alcohol in a quiet residential area and amplified music being played up to 11pm three nights a week would be a tremendous intrusion for the neighbouring houses. Children play in our road, an increase of persons under the influence of alcohol wandering the streets locally would be an unacceptable risk to them.
<b>Public safety</b>	During matches, the parking around the sounding areas and our estate are dangerous. Cars are parked dangerously and illegally on the junction posing a very real danger to our children on their bikes who are more difficult to be seen. The increase of traffic would escalate this threat.
<b>To prevent public nuisance</b>	As above, the proximity of the football venue to quiet residential housing is far too close. My son is a light sleeper, he is only very young and the proposed music venue is only a stone throw away from his window. He has suffered with whooping cough and other medical issues in his younger years and I am concerned that the music will be loud enough to cause him considerable anxiety. His bedtime is at 7pm.
<b>To protect children from harm</b>	As mentioned above, I believe the parking issue which a major issue already will only become worse. There is illegal parking already taking place. It is only luck that has kept children playing on their bikes from serious harm.
