The Planning and Licensing Committee of Ashby de la Zouch Town Council met on Monday 9 <sup>th</sup> October 2023 to discuss, amongst other matters, the licensing application for XXX Buns Ltd. The members of the Licensing Committee resolved to object to the application on the grounds detailed below.
The Chairman of the Committee wishes to attend before the Licensing Sub-Committee of NWLDC to make representations on behalf of the Town Council.

<b>Licensing Objective</b>	<b>Please provide full details of your concerns regarding the application and include any evidence you may have in support of it. Please use separate sheets if necessary</b>
<b>To prevent crime and disorder</b>	As evening access to the premises, which are attached to the back of the Town Hall building, is along a small, isolated alley that connects South Street to Market Street, there is concern that this area will not have sufficient security and the presence of licensed premises, with outside drinking permitted on a terrace area, is likely to increase crime in the area. The applicant states that door security staff will only be provided , “ <i>where I consider them necessary</i> ”. This is wholly inadequate as security will rely upon the subjective judgement of the licensee.  We would draw attention the fact that the application premises lie at the centre of the Ashby Cumulative Impact Zone (CIZ), where “ <i>the number of premises licences and club premises certificates are such that it is likely that granting further licences or variations to existing premises licences and/or club premises certificates would be inconsistent with our duty to promote the licensing objectives</i> ”. The CIZ was reviewed and renewed very recently (February 2022) with full police backing.
<b>Public safety</b>	The courtyard access to the premises is shared by a taxi firm with poorly defined discrimination between pedestrians and vehicles. Currently taxi vehicles have to reverse in or out of their parking spaces which is likely to lead to collisions with pedestrians accessing and leaving the licensed premises.

<b>To prevent public nuisance</b>	There is currently just one takeaway establishment on Bakery Court, meaning customers arrive and depart relatively quickly. This application is a restaurant and is proposing both indoor and outdoor seating meaning a significant increase in noise in the area from customers dining in and outside the establishment. The noise is likely to be heard by inhabitants of town centre dwellings, particularly premises that back on to, and are situated, on South Street (South Street consisting of predominantly residential dwellings).
<b>To protect children from harm</b>	There is a gym/boxing club situated on Bakery Court directly next door to these premises that provides exercise and training for children of all ages, many of whom gather outside the gym, beside the application premises outside balcony, before and after their training sessions. The Committee is concerned that children using gym will be subject to inappropriate comments & language from intoxicated customers of XXX Buns Ltd with the possibility of more severe harm.
